INSTRUCTIONS FOR COMPLETING THE PROXY FORM

Appointing a proxy

A Unitholder entitled to attend and vote is entitled to appoint no more than two proxies to attend and vote at this AGM as the Unitholder's proxy. A proxy need not be a Unitholder of the Trust. Where more than one proxy is appointed, each proxy may be appointed to represent a specific proportion of the Unitholder's voting rights. If such appointment is not made, then each proxy shall exercise half of the Unitholder's voting rights. Fractions shall be disregarded. If the proxy is also a Unitholder, the proxy can cast any votes the proxy holds as a Unitholder in any way that the proxy sees fit.

Direction to vote

A Unitholder may direct a proxy how to vote by marking one of the boxes opposite each item of business. Where a box is not marked the proxy may vote as they choose subject to the relevant laws. Where more than one box is marked on an item the vote will be invalid on that item.

Signing instructions

<u>Individual</u>: Where the holding is in one name, the Unitholder must sign.

Joint holding: Where the holding is in more than one name, all the Unitholders should sign.

Power of attorney: If you have not already provided the power of attorney to the registry, please attach a certified copy of the power of attorney to this Proxy Form when you return it.
